



Before completing this application you must read and understand the **Heritage Energy Retrofit Grant Terms and Conditions**.

Your Energy Advisor will help you decide on the retrofits that will benefit your home. You are not obligated to pursue any or all retrofits, but it is important to understand which retrofits will qualify for funds from the Heritage Energy Retrofit Grant pilot program.

Successful candidates must meet the following criteria:

- The house is on the City of Vancouver Heritage Register **or** was constructed before 1940
- The primary heating type is oil *or* natural gas (*electric heating does not currently qualify, see Terms and Conditions*)
- Applicant is the current resident owner of the house
- The house is either a detached single-family residence, duplex, row home or townhouse with independent energy metering
- The applicant agrees to hire a Heritage Energy Retrofit Grant program Energy Advisor to conduct pre- and post-retrofit evaluations
- The applicant initiates a pre-retrofit evaluation and retrofit work within 45 days of receiving approval of inclusion in the pilot grant program. Applicants are encouraged to complete retrofits within 3 - 6 months of completing the pre-retrofit evaluation. Vancouver Heritage Foundation (VHF) reserves the right to reallocate grant funding if approved applicants choose not to pursue the grant within this time frame.

An **Application for Reimbursement** will be required in order to receive funds only after the following steps are completed:

- The Heritage Energy Retrofit Grant Application is approved by VHF
- An Energy Advisor is hired by the applicant to conduct a pre-retrofit evaluation and offer recommendations
- One or more of the recommended retrofits are implemented and;
- A post-retrofit evaluation is conducted by the Energy Advisor.

The Application for Reimbursement will be provided by the Energy Advisor or VHF after you have been approved to participate in the pilot grant program. The value of the grant you receive will be determined by the greenhouse gas (GHG) reductions achieved by the retrofits implemented on your home. These will be calculated by City Green Solutions using the energy evaluations and the Vancouver GHG Grant Calculator.

The pilot Home Energy Retrofit Grant program is open from September 2015 to August 31, 2016 but a limited number of homes will be approved to participate. You are encouraged to apply early and hire an Energy Advisor to conduct your pre-retrofit evaluation and then get started immediately on your retrofits if you are approved to participate.

Please ensure you have completed the form in full prior to submitting your application. Only the section on Page 2 "Please indicate to the best of your ability the energy retrofits that the house may benefit from" does not require you to fill in information in all the fields.
